



Application Deadline Extension

WASHINGTON, Sept. 22, 2023 – The U.S. Department of Agriculture is extending the deadline for the Discrimination Financial Assistance Program to January 13, 2024, to give eligible farmers, ranchers and forest landowners more time to apply for assistance. The original deadline was October 31, 2023. This deadline extension is responsive to feedback from potential applicants, nongovernmental program administrators and community-based organizations working closely with USDA to inform and assist eligible individuals. The new deadline will allow more time to reach and help farmers, ranchers and forest landowners through direct, no-cost technical assistance and training sessions. The extension will also ensure everyone has adequate time to apply, including producers whose harvest season falls during the original application period.

"USDA knows it must earn the trust of the farmers, ranchers and forest landowners who are eligible for this program. That makes transparency in the administration of the Discrimination Financial Assistance Program crucial," said Agriculture Secretary Tom Vilsack. "In that spirit, after receiving feedback from organizations that have been supporting producers throughout the application process, we have made the decision to extend the deadline. We believe this is the appropriate action to take to ensure all eligible individuals wishing to apply are adequately informed about the program and have the opportunity to receive any necessary assistance."

Since the opening of the financial assistance application process on July 7, the Discrimination Financial Assistance Program team has embarked on a nationwide outreach campaign and quickly opened 30 local offices across 26 states. Regional administrators have held well over 600 virtual and in-person events across the country. Cooperators have also held dozens of virtual and in-person events to complement these efforts while also educating their specific networks. Advertising on digital, print and radio channels targeting potentially eligible individuals and rural communities has also been deployed. These efforts have successfully allowed program staff to reach many potential applicants and will be further increased with the new, extended deadline.

This program delivers on Section 22007 of the Inflation Reduction Act, which provides financial assistance for farmers, ranchers and forest landowners who experienced discrimination in USDA farm lending programs prior to January 2021. Congress provided a total of \$2.2 billion for this program. The amount of money awarded to individuals through this program will depend on the number of eligible applicants and the consequences of the discrimination. Eligible individuals have the option to apply online or by submitting paper-based forms via mail or in-person delivery to local program offices. Applicants are not required to retain an attorney and should take precautions to protect themselves from potential scams.

In addition to the application deadline change, the deadline to request records from USDA's Farm Service Agency for use in applications has been extended to Friday, Nov. 3, 2023. The application process was designed so that FSA records are not required, though relevant records may be attached to an application as additional evidence if they are available.

ALCDC DRONE

An agricultural drone, otherwise known as an unmanned aerial vehicle (UAV), is used to watch the health of trees, land, and crops using hightech sensors and digital and satellite imaging to supply comprehensive information about the land. These drones give the user the option of either watching live video footage while the drone is in flight or downloading the material to watch later.

These clever flying bots can remotely detect land and crop damage from insects, weather conditions, wildfire, and construction; they can show

which crops need nutrients, estimate yields, and even count cattle. Arkansas Land and Community Development Corporation uses its drone to help watch its cattle, farm visits, and many other applications.

The advantage of a drone is that it gives aerial perspective and analysis, allowing a producer to diagnose problems that are not always clear at eye level.

The key components of ALCDC drone demonstration center consist of a PC and monitor used for drone data processing and as a flight simulator for training UAU/Drone Pilots, audio, visual equipment for training, meetings/briefings support, and airport maps, weather charts, logbooks, flight plans, charts etc.

Our Youth Enterprises and Career in Agriculture and Entrepreneurship (YECAE) and EXCEL students in our summer program also came to see the possible uses of smaller drones to show.





Recently we conducted a drone demonstration in Twin Grove at Shane Foster Farm, and in Holy Springs, Woodson Walker Farms, illustrating applications for drones in variegated disciplines, from architecture, engineering, and operations, to supply chain management and agriculture.

"It weighs under 55 pounds, can fly in a lot of different environments. Using drones can make agriculture safer and more efficient, where "agriculture is so important."










True Story by Agnes Lucas Handcock Matriarch of ALFDC An Arkansas Black Farmer



I grew up on a 500-acre farm in St. Francis County, Arkansas. I had a good life with my father and mother. They were ranchers who raised cows and sold cream. For our family to survive, we also raised cotton, corn, sweet potatoes, and other vegetables. We also prepared food for cold chilly winter days. All be thankful your land is yours. It will love you back (Psalms 37:11).

In 1950, I became a farmer's wife. We grew cotton, corn, peas, soybeans, and rice. I helped with the farm work and prepared food for the family. We were blessed with eight children. We made sure that our children finished high school and went on to enter college, the military, or the workforce. In the early 1980s, I oversaw the 500-acre Lucas Family Farm and the courts tried to sell it. That is when the Arkansas Land and Farm Development Corporation (ALFDC) began its first case to help save Black farmers' land. I thank ALFDC for leading the charge to save the land of Black farmers in Arkansas.

Thomas Vaugh a True Patriot of ALFDC



Thomas Vaughn was drafted into the U.S. Army Air Corps during World War II, where he was one of eighteen out of 400 veterans in his squadron selected to train as a Tuskegee Airman Aircraft Mechanic (1942-46).

Mr. Vaughns was an Instructor for Veterans, a Cooperative Extension Agent in Crittenden County, Arkansas and a Horticulture Specialist, University of Arkansas at Pine Bluff. Mr. Vaughns used his ability to help small farmers who were in economic crisis to save their farms and maximize their profits. While at UAPB, Mr. Vaughns was appointed by then Governor Bill Clinton to the Arkansas Farm Advisory Board. In that role, Mr. Vaughns helped shape policy decisions that affected small farm families in the state.

His agricultural service and leadership led to the establishment of the Arkansas Vegetable Growers and Market Association Cooperative and later, the Farmers' Market in Pine Bluff and in Little Rock



USDA Launches Program to Support Agricultural Employers and Farmworkers, Aiming to Increase Economic and Supply Chain Resilience as Part of President Biden's Investing in America Agenda

WASHINGTON, D.C., September 22, 2023 – The Biden-Harris Administration today announced that agricultural employers can begin to apply for a pilot program designed to improve the resiliency of the food and agricultural supply chain by addressing workforce challenges farmers and ranchers face. The U.S. Department of Agriculture (USDA), in

coordination with other federal agencies, is announcing up to \$65 million in grants available for the Farm Labor Stabilization and Protection Pilot Program (FLSP Program).

The program will help address workforce needs in agriculture, promote a safe and healthy work environment for farmworkers, and aims to support expansion of lawful migration pathways for workers, including for workers from Northern Central America, through the Department of Labor's seasonal H-2A visa program. The program makes good on a commitment made and announced as part of the Los Angeles Declaration on Migration and Protection and is funded by President Biden's American Rescue Plan.

"Our country is facing growing agriculture workforce challenges that jeopardize our farmers' ability to be competitive, threaten the resiliency, abundance and safety of our food system, and has repercussions on our overall economy. At the same time, record numbers of people are interested in living and working in the United States, including from Northern Central America," said Agriculture Secretary Tom Vilsack. "This pilot program has been designed with significant input from immigration, labor, and agricultural stakeholders in an effort to help address these immediate challenges. The program will provide incentives designed to simultaneously benefit workers and employers, with the potential to inform the H-2A program, raise labor standards for farmworkers, and help alleviate our agricultural workforce challenges over the long term. In addition to helping agricultural producers recruit and retain workers, at the end of the program we will have tested new ways to promote accountability and improve working conditions for domestic and H-2A workers alike – demonstrating how employers' benefit by doing right by workers. The effort will also facilitate safe, orderly, and humane migration. This pilot should be a win for everyone along the agricultural supply chain, from the field to the dinner table."

The FLSP Program seeks to advance the following Administration priorities:

Address current workforce needs in agriculture: Based on stakeholder input, USDA identified that agricultural employers have experienced increased challenges finding an adequate supply of workers, which threatens our domestic capacity to produce a safe and robust food supply. This pilot program will help address these challenges by expanding the potential pool of workers, and enhancing employers' competitiveness by improving the quality of the jobs they offer.

Reduce irregular migration, including from Northern Central America through the expansion of regular pathways: While U.S. agricultural operations seek additional workers, the Biden-Harris Administration has committed to promote the expansion of regular migration pathways, as part of the Los Angeles Declaration on Migration and Protection. The FLSP offers an opportunity to support this commitment, with economic benefits for foreign workers and their families, and professional and economic development opportunities for communities that send their workers to participate in the H-2A program. Improve working conditions for farm workers: A stable and resilient food and agricultural sector relies on attracting and retaining skilled agricultural workers, and strong working conditions are critical to achieve that goal. Through this pilot program, USDA will support efforts to improve working conditions for agricultural workers, both U.S. and H-2A workers. The pilot will help ensure that workers know their rights and the resources available for them, and will promote fair and transparent recruitment practices.

Additional Information

Eligibility for this competitive grant program is limited to domestic agricultural employers who 1) anticipate meeting all Department of Labor (DOL) and Department of Homeland Security (DHS) regulatory requirements for the H-2A program, including demonstrated effort to effectively recruit U.S.-based workers and hire all willing, able, and qualified U.S. workers; and 2) commit to, and indicate capacity to fulfill all Baseline Requirements, as well as any selected (supplemental) commitments that entail additive worker benefits and protections. Eligible employers include fixed-site employers, joint-employers, agricultural associations, and H-2A labor contractors.

The maximum award amount is \$2,000,000 and the minimum amount is \$25,000 per grant agreement (including any sub-awardees). Award amounts will be determined based on the projected number of full-time equivalent (FTE) agricultural employees, desired award level, as well as the competitive nature of the application. Consistent with the H-2A requirements, applicants must demonstrate insufficient availability of a U.S.-based workforce. The grant window for each recipient is 24 months, allowing producers to use the grant over the course of two agricultural production seasons.

Applications for the FLSP program must be received on or before 11:59 pm Eastern Time on November 28, 2023. More information about the application process can be found here: www.ams.usda.gov/flsp.

This announcement is part of the Biden-Harris Administration's Investing in America agenda to grow the American economy from the middle out and bottom up by rebuilding our nation's infrastructure, creating good-paying jobs, and building a clean energy economy to tackle the climate crisis and make our communities more resilient.

The event engaged participants in round table discussions that included Dr. Calvin King Sr. and staff, Mayor Darin

Davis, council, and city members, NRCS Staff Tresel Benjamin and staff, FSA representative Theodore Eldridge Jr., and Nitosha Berry, along with community partners and stakeholders. Discussions focused on challenges, shared best practices, and innovative solutions for Equity and Equality Program Resource Opportunities.

- Drones in Agriculture
- Solutions and Resources to Address Heir Property Challenges
- Farm Certification, Alternative Crops, Local Food Supply, Marketing, Access to Farm Financing, and Farm support program services and opportunities for beginning farmers, ranchers,
- and veterans. ➤ Discussion on the Section 22007 Application for Discrimination Financial Assistance update.



The event included financial resource opportunities in the new federal legislation, the Inflation Reduction Act (IRA), and the American Rescue Plan (ARP) in addition to NRCS and FSA Resource Opportunities.

USDA Announces Additional Program Payment for Rice Producers in Arkansas

Second production payment for rice farmers impacted by record high input costs in 2022.

LITTLE ROCK, AR, Sept. 22, 2023— The U.S. Department of Agriculture (USDA) today announced that rice producers will receive an additional payment through the Farm Service Agency's (FSA) <u>Rice Production</u> <u>Program</u>, which provides up to \$250 million in assistance to rice farmers based on 2022 rice acres. "While increased input costs have impacted many agricultural producers, record high increases in 2022 had a disproportionate economic impact on rice producers," said Doris Washington, State Executive Director for FSA in Arkansas. "I am pleased that Congress authorized the funding needed to not only provide one payment to State's rice producers, but also sufficient funding to now provide an additional payment. This financial assistance provides a much-needed capital inject for rice production."

On Dec. 29, 2022, President Biden signed into law H.R. 2617, the Consolidated Appropriations Act, 2023, which provided the authority and funding for USDA to make payments to rice producers based on data already on file with USDA, including planted acres and acres prevented from being planted.

Payments

As part of FSA's efforts to streamline and simplify the delivery of additional Rice Production Program benefits, producers are not required to submit a new application for the additional Rice Production Program payment. Rice producers having a previously approved Rice Production Program application and who received an initial program payment, will receive an additional payment of .28 cent per pound based on previously reported data. FSA made an initial payment to eligible producers at a reduced payment rate of one cent per pound, making the total overall payment rate \$1.28 cent per pound.

Payment Limitation

The payment limitation for the program is set by statute and is higher if the farmer's average adjusted gross farm income (income from activities related to farming, ranching or forestry) is more than 75% of their average adjusted gross income (AGI). Specifically, a person or legal entity with an average AGI of less than 75% of their average AGI cannot receive, directly or indirectly, more than \$125,000 in payments. Farmers who derive 75% or more of their average AGI from farming qualify for a \$250,000 payment limit. AGI is based on the three taxable years preceding the most immediately preceding complete tax year.

In advance of the initial payment, rice farmers were to visit their local county office to submit the appropriate form and certification (FSA-510, *Request for an Exception to the \$125,000 Payment Limitation for Certain Programs)* by Sept. 8, 2023, if they were requesting the higher payment limit.

SECTION 22007 DISCRIMINATION FINANCIAL ASSISTANCE PROGRAM UPDATE ON FSA RECORDS

Eligible farmers, ranchers, and forest landowners wishing to request their records from FSA to support their applications can continue to submit requests, and the agency will work to expedite records searches as quickly as possible. The prior deadline for these requests (September 6) has been extended to September 29.

The DFAP application process was designed so that FSA records are not required, though relevant records may be attached to an application as additional evidence if they are available. Where possible, FSA has already provided digital records to the program administrators to assist them as they conduct the program. If you still wish to request records from the FSA, the agency will search for records and provide copies of any relevant documents located in the search.

Due to the amount of time that may have passed, USDA recognizes that some records may no longer be in FSA's possession. FSA follows government record retention schedules that indicate which farm records should be kept after a designated period. Even if no FSA records are available, you can provide other evidence to show you were a farmer or intended to farm and experienced discrimination in USDA farm lending.

Records requests must be submitted in writing. This can be done by emailing <u>info@22007apply.gov</u> no later than Friday, September 29, 2023. If you do not have an email address, you can go to your local FSA office or call 800-721-0970 to receive information about where and how you can submit a request in writing. Uniform Heir Property Act Summarization



Arkansas Uniform Partition of Heirs Property Act of 2016


The Uniform Partition of Heirs Property Act utilizes a court appointed disinterested real estate appraiser to assess the fair market value of the property, unless all the cotenants agree on the value of the property, or the court determines that the cost of the appraisal will outweigh its evidentiary value.

- Upon determination of the value of the property, the Act provides all the cotenants who did not request partition by sale, with a right to buy all of the interests of those who have done so, at a price equal to the court-determined value of the property, multiplied by the fractional interest of the cotenant that is bought out.
- The applicability of the law applies when an action to partition real property, the court shall determine whether the property is heirs' property. Upon determination by the court that said property is heirs' property, the property must be partitioned under this subchapter (partition in kind) unless the court finds "partition in kind" will result in great prejudice to the cotenants as a group.

The new Act provides important additions to the existing state law with protections against unexpected and often devastating predatory speculation. The determination of the courts whether the property is heirs' is a mitigating factor waiting for an answer.
